



Local Excursion Consent Form 2025

In 2025, Roberts McCubbin Primary School may take students outside of school grounds to undertake educational activities in the local area.

The purpose of this form is to obtain parent/carer consent for local excursions during 2025.

This form does NOT provide consent for excursions that go beyond the local area.

Local excursions

Local excursions are excursions to locations within walking distance of the school and do not involve 'Adventure Activities'.

Local excursions that your child may participate in throughout 2025 could include (but are not limited to):

- Activities at local parks, eg Artist's Park, such as the Teddy Bear Picnic
- Walking to local sporting facilities or nearby schools for sports events
- Visiting local kindergartens or child-care facilities
- Visiting shopping complexes or Aged Care Facilities as part of a choir
- Using aspects of our local streets and parks in practical applications of the mathematics or science curriculum

Notification of local excursions

Roberts McCubbin Primary School will NOT seek further consent from you before local excursions take place. However, we will provide advance notice to parents/carers of upcoming local excursions through Compass.

For local excursions that occur on a recurring basis, Roberts McCubbin Primary School will notify parents/carers once only prior to the commencement of the recurring event, eg; weekly sports lessons at the local oval.

Please keep the school informed of any updated contact details to ensure you receive these notifications.

First aid and Medical Attention

Where necessary, school staff will administer first aid. School staff will also seek emergency medical attention for your child if it is considered reasonably necessary. Any costs associated with student injury rest with parents/carers unless the Department of Education and Training is liable in negligence (liability is not automatic).

Accident and ambulance cover

The Department of Education and Training does not provide student accident insurance or ambulance cover. Parents may wish to obtain this cover, depending on their health insurance arrangements and any other personal considerations.
